About the Boston Bar Summer Fundraiser

Who?

- ◇ **The Summer Fundraiser draws approximately 250 members of the Boston legal community. Attendees are primarily young lawyers within the first ten years of practice, law students and summer associates at area law firms, and young leaders in the legal community.**
- ◇ **The Boston Bar Association is a organization with over 13,000 members. All electronic marketing is distributed to the entire BBA membership.**

What?

- ◇ **The event features an incredible evening of food, drinks and networking that benefits a great cause.**

Where?

- ◇ **The event takes place at 16 Beacon Street, throughout two floors of the historic Beacon Hill townhouse that is the Boston Bar Association's headquarters.**

When?

- ◇ **Thursday, June 29, 2017 from 6:00 p.m. - 9:00 p.m.**

Why?

- ◇ **The event raises money to fund the public service projects and community service work of the Boston Bar. Each year, these projects engage hundreds of lawyers in helping thousands of people in need in our city. Some of the projects that benefit from this event include:**
 - ◇ **The Military & Veterans Legal Help Line**— *As part of an ongoing effort to provide much-needed legal assistance to service members and veterans, the Help Line connects veterans, military personnel and their families with lawyers and other legal resources appropriate to their needs.*
 - ◇ **The Law Day in the Schools Program**— *Throughout the spring, volunteer lawyers visit Boston Public School classrooms from grades K-12, teaching lessons on the Magna Carta, Miranda rights and, this year, due process. This program gives students a firsthand look into the legal profession and helps teach them about the importance of the justice system.*
 - ◇ **The Financial Literacy Program**— *This program provides Boston youth with one of the most important skills they can have—financial literacy. Volunteers educate students about budgeting, using credit cards, the perils of falling into financial trouble and more.*
 - ◇ **Lawyer for a Day in the Housing Court**— *This program provides crucial advice and assistance to unrepresented landlords and tenants navigating the Housing Court system. Since 1999, over 15,000 individuals have been helped - making all the difference for individuals and families who are facing the loss of their homes as well as landlords who are in need of a better understanding of their rights.*
 - ◇ **The Reentry Education Program**— *After incarceration, rejoining society again is no easy task. Individuals face obstacles in regaining their licenses, finding jobs, securing housing and other basic needs—obstacles that can be difficult to navigate without assistance. This program provides sessions for probationers that are led by volunteer attorneys, to help them prepare to reenter society.*
